WE ARE LOOKING FOR LEADERS

We often think we are not leaders, but we are seasoned leaders. As a mom or grandmother, we model and expect good behavior from our young ones. We lead them in the right direction. In the workplace, we demonstrate leadership by being an attentive and responsible employee. When a group of club women gather at the Boys and Girls Club to drop off backpacks with food or show up at the library to read to preschools, they are leaders. We do it every day.

Some of us lead the Pledge of Allegiance at our club meeting. We start it, and the members follow. Some of us plan a club meeting and lead our club members in the direction of doing valuable and fruitful work. Being club president takes time, and most women are happy they took the challenge to make themselves grow. Indiana Federation of Clubs is also looking for women who are adventurous enough to become a state officer and assist in leading Indiana club women. To be a state officer you must have served as a club president, and you must have served or currently are serving as a program or committee chairman. You already know how to lead, now share your talent.

PLEASE CONSIDER THE FOLLOWING STATE OFFICER POSITIONS

Treasurer: Officer must be present at annual convention in the spring; receive and disperse payments through the IFC checking account; balance monthly statements; have knowledge of or be willing to learn how to "bank online"; prepare quarterly financial report; work with President elect to set a budget for the upcoming year; be present once a year for a review of records; participate in two to three online board meetings; be willing to consider moving up in IFC leadership.

Secretary: Officer must be present at annual convention in the spring; take the minutes of annual convention and two to three board meetings according to approved format (you will have assistance), and share with the board; participate in two to three online board meetings; assist with state correspondence received; assist with elections, as needed; be willing to consider moving up in IFC leadership.

President-Elect: Officer must have previously served on the board for at least one other office; officer must be present at annual convention in the spring; oversee the financial health of IFC and work with the treasurer in preparing an annual budget; as Dean of the Districts be available to answer questions from District Presidents and correspond as needed; participate in two to three online board meetings; Officer must be willing to move up to position of State President. In preparing for State President, other duties are also required such as correspondence and travel to GFWC meetings, preparing the IFC annual directory, corresponding with the great members of Indiana Federation of Clubs.

PROPOSED AMMENDMENTS TO THE BYLAWS

The Bylaws committee and current GFWC/IFC officers wish to make the following Ten (10) changes to the Bylaws. These changes will be voted on at the 2020 Convention.

#ONE

Under ARTICLE 111. MEMBERSHIP

Section 2. Classification

There shall be ~~six (6)~~ **five (5)** classifications of membership:

PROPOSED TO REMOVE

Current Bylaw:

~~D. County Clubs, a majority of whose members come from more than one city or town, shall be classified as County Clubs.~~

RATIONALE- The State no longer has Counties or County Clubs

Note: If the delegates at Convention adopt this amendment, all references to County and County Clubs throughout the bylaws will be deleted.

#TWO

Under ARTICLE V. OFFICERS

Section 2. Eligibility

Current Bylaw:

- A. Only members of clubs in active membership shall be eligible to hold office.
- B. No person shall be eligible for the office of President-elect who has not at some time served as a member of the Executive Board for at least two (2) years.
- C. Other officers must have been members of the Council for at least two (2) years.

PROPOSED TO INSERT

D. A Pro-Tem officer shall be appointed by the Executive Board and only serve for the short term necessary. They must run for office in the following election and meet all qualifications at that time.

RATIONALE-Verification

Current Bylaw:

B. Yearbook/Directory

1. The incoming President shall edit all sections of the yearbook pertaining to the incoming administration.

RATIONALE- Clarification that "yearbook" and "directory" are the same.

Note: If the delegates at Convention adopt this amendment, all references to "yearbook" or "directory" will be changed to "yearbook/directory" throughout the bylaws.

B. Yearbook/Directory

2. The incoming President shall be responsible for forwarding all materials.

2. The incoming President shall be responsible for forwarding all materials, **to the Parliamentary Advisor for review and corrections before distributions.**

RATIONALE-Prevention of errors in information

#FIVE

Under ARTICLE V. OFFICERS

Section 6. Responsibilities

Current Bylaw:

10. Shall supervise of the publication CLUBWOMAN and the yearbook/directory for the term of office.

PROPOSED TO INSERT

Words **"the distribution" after supervise and before of the publication**

RATIONALE- Clarification the President will supervisor distribution.

17. Shall, in coordination with the Second-Vice President, schedule a meeting of all Departments and appropriate Special and/or Standing Committee Chairmen, prior to the council meeting, for the purpose of planning their area of work.

Section 7. Miscellaneous Responsibilities

Current Bylaw:

B. Each officer shall keep a complete record of work done during the administration and deliver all records and copies the successor at the close of the term of office.

PROPOSED TO INSERT

Words **“on an external drive to assist”** after copies and before the successor.

B. Each officer shall keep a complete record of work done during the administration and deliver all records and copies on an external drive to assist the successor at the close of the term of office.

RATIONALE- Easier for successor to carry, review, and have permanent record

Candidates who have declared their intention shall submit a biography and a picture for printing in convention issue of the publication. This shall be sent to the Editor by the deadline date.

Section 6. Elections Committee

A. Composition

The committee shall consist of a chairman and three (3) committee members who represent a majority of the Districts.

B. Responsibilities

- 1. Receive the names of candidates for office.
2. Verify the eligibility of such candidates.
3. Place on the ballot the names of candidates eligible to hold office.
4. Prepare printed ballots
5. Be responsible for voting facilities
6. Conduct the election
7. Report the results at the scheduled time

C. Exception

In the event of an uncontested election the outcome may be determined by a voice vote.

SUBSTITUTE

Section 6. NOMINATIONS/ELECTIONS COMMITTEE

A) Composition

Section 1. The Nominating/Elections Committee for GFWC/ Indiana Federation of Women's Clubs shall consist of an elected member from each District. No member shall serve two consecutive terms on the Committee. -

Section 2. A chairman shall be elected by the Board of Directors at the Post-Annual Meeting (Convention) Board of Directors meeting in the odd numbered years.

B) Responsibilities

Section 1. The President of the GFWC/Indiana Federation of Women's Clubs shall call for a meeting of the Nominating/Elections Committee between November 1 and December 1 in the odd numbered years. She shall instruct the members as to their duties and responsibilities.

1. Candidates for office need to request letters of recommendation and have them sent to the chairman.
2. Letters of recommendation will be copied by the chairman and sent to each of the committee members prior to meeting to allow each member time to read the letters.
3. The committee shall verify eligibility of candidates:

Section 2. The Nominating/Elections Committee Chairman shall submit to *Indiana Clubwoman* Editor the list of candidates for officers and their credentials to be published in the spring issue of *Indiana Clubwoman*.

Section 3. It shall be the duty of the Nominating/Elections Committee to present, on the first day of the Annual Meeting (Convention) in the even-numbered years, a list of candidates for officers of the GFWC/Indiana Federation of Women's Clubs.

Section 4. The same day the report of the Nominating/Elections Committee is presented, an opportunity shall be given for nominations from the floor for all offices except State President. Candidates so nominated from the floor shall have consented to be nominated and shall meet the bylaw requirements of eligibility. The Nominating/Elections Committee Chairman will be charged with verifying eligibility.

Section 5. All candidates shall be introduced to the Annual Meeting (Convention) assembly before the balloting begins. All candidates' names shall be placed on prepared and printed ballots.

Section 6. The Nominating/Elections Committee shall be responsible for conducting the election, including the printing of the ballots and obtaining the voting facility. The Chairman of the Committee will report the election results. In the event of an uncontested election the outcome may be determined by a voice vote.

Section 7. In the event a candidate for office withdraws her name before election, the President shall call for a special meeting of the Nominating Committee as soon as possible to select another candidate(s).
